

Use Regulations



To maintain the public nature and safety of the hotel and to ensure a comfortable stay, guests using our hotel are required to abide by the following rules based on Article 10 of the Accommodation Terms and Conditions. Failure to comply with these rules may result in the cancellation of your stay in accordance with Article 5 of the Accommodation Terms and Conditions.

Notice

1. For Fire Prevention Purpose

- (1) Do not use irons other than the rental equipment or any burner for heating and/or cooking within the room and lobby areas.
- (2) Be careful not to do anything apt to become causes of fire.

2. For Security Purpose

- (1) When leaving the room, make sure the door is closed firmly.
- (2) To leave your belongings in the hall or the lobby.

3. Refrain from the Followings

- (1) Inviting visitors to your room and letting them use the fixtures and equipment of the room.
- (2) Not to enter the guest room except the registrant.
- (3) To give annoyance to the others by making a great noise or disgusting behaviors, playing loud music, turn the television or radio volume high, etc.
- (4) To bring the followings into the room, lobby or the hall.
 - (a) Animals, birds, etc., excluding assistance dogs.
 - (b) Things unclean or with loathsome smell.
 - (c) Goods of great quantity.
 - (d) Explosive items such as powder, gasoline, etc.
 - (e) Illegally owned guns and swords.
- (5) To gamble or behave in a demoralizing manner in this hotel.
- (6) To use the furniture and fixtures in the room, lobby or the hall for the purpose other than the original object.
- (7) Not to move or take away the furniture and the fixtures in the room or the hallway to any other place.
- (8) To use the room or the lobby as business offices, etc., contrary to lodging purpose.
- (9) To deliver advertising material or sell goods to other guests in this hotel.
- (10) Please refrain from eating and drinking in the lobby.
- (11) Please refrain from using the lobby or restaurant, except for accessing the public bath, while wearing nightwear, slippers, etc.

4. Regarding the Service for Valuables

Please use the safe in the guest room for your valuables. Our hotel cannot be responsible for the loss or theft in the room or any other places if it would happen.

5. For Deposited Items

- (1) Items deposited in the cloakroom.....one month
- (2) Pieces of washing requested from the laundry.....one month
- (3) Forgotten and misplaced items, i.e. lost property.....in the hands of the authority

6. Regarding the Use of the Bathhouse

- (1) Please take a towel and body towel with you from your room.
- (2) Please lock the locker and be careful of the loss of the key. In case you have lost the key, our hotel will ask you for the expense.
- (3) Please be sure that our hotel cannot be responsible for the loss or theft of your valuables in the bathhouse.
- (4) The bathhouse is for the guests only. Anyone except guests cannot use the bathroom.
- (5) Anyone connected to an organized group of gangsters or tattooed, sealed cannot use it.
- (6) A case of infectious disease is not accepted in using it.
- (7) A drunken person is firmly not permitted to use it.
- (8) No smoking in the bathhouse.
- (9) Laundry and hair dyeing are prohibited.
- (10) It is prohibited to take a photograph in the bathhouse. Also the use of cellphones or smart phones is prohibited there in order to avoid any troubles among guests.

7. Settlement of Accounts

- (1) For extended stays, please pay your hotel charge. Settle your accounts each time a bill of statement is delivered to you.
- (2) No payment will be made on behalf of the Guest for such expenses as shopping at the hotel, tickets, taxi fares, postage, or other similar charges.

8. Make Use the Parking

When using the hotel's parking lot, the management takes no responsibility for any accident that may occur in the lot.

9. Closing Time

There is no closing time in our hotel.

Our hotel is to lock the front door for security from 2:00 a.m. until 6:00 a.m. If you let us know of your return to the hotel through the intercom, we will then open it.

10. Language

These use regulations are provided in both Japanese and English. In case of a discrepancy between the Japanese and the English, the Japanese version will take precedence.
