# The Regulations for Deposited Items



## 1. The Duration of Deposit

- (1) The duration of deposit shall be from the day when the Hotel receives the deposited items until the day of the appointed day by the Guest.
- (2) The appointed return day is limited to be within a month from the day when the Hotel received the deposited items.
- (3) In the case the Guest does not appoint the day of receiving the deposited items, the duration of deposit shall be one month from the deposited day.

#### 2. Deposited Items

The Hotel regrets not accepting dangerous, perishable or breakables. Also, animals, plants, fabrics easily damaged by insects and fur goods.

## 3. The Recipient

The recipient of the deposited items shall be the guest oneself or a third person whom the recipient appoints for the return.

#### 4. Confirmation of the Recipient

The recipient or a third person who was authorized shall be asked to show the deposit receipt to the Hotel Staff when asking for receiving the deposited items. In case the recipient is a third person who was appointed by the guest, the recipient may be asked to show the one's identification. The Hotel Staff shall carefully check whether the recipient is the right person to receive them by confirming the name of the recipient and the Guest. After confirmation the deposited items shall be returned to the recipient. In this case the Hotel shall not be liable for the deposited items.

#### 5. Compensation for Damages

- (1) The Hotel shall not be liable for the loss, breakage, deterioration or other damage of the deposited items caused by an inevitable accident.
- (2) The damage shall be compensated to the Hotel or a third person in case of breakage, deterioration or other damage of the deposited items for the reason of the Guest's responsibility.

## 6. Disposal of the Deposited Items

- (1) In case that there is no receipt of the deposited items within a week after expiry of the deposit duration, the Hotel shall keep them in the ordinal way and then dispose by generally acknowledged method, time, value, etc. If the Hotel finds the above case difficult, it shall dispose of the deposited items.
- (2) The Guest shall be liable for the expense of the disposal in case of (1). The price accrued by the disposal, however, shall be applied to the expenditure of the disposal.

## 7. Emergency Measures

- (1) The Hotel shall take measures suited to the occasion in case where the below situations occur.
  - (a) In case that the judicial organ claims for the disclosure of the deposited items, or
  - (b) In the situation of a fire, unusual phenomenon of the deposited items or other states of emergency
- (2) The Hotel shall not be liable for any damage of the deposited items caused by either above case.

## 8. Language

These regulations are provided in both Japanese and English. In case of a discrepancy between the Japanese and the English, the Japanese version will take precedence.

### 9. Jurisdiction and Governing Law

Any dispute caused in accordance with these regulations shall be solved through the Japanese governing rules from the Japanese court that controls the region of the Hotel.
